3. Why This Policy Is Required

This policy is required for app usage because:

- Critical Updates: Security and bug fix updates are essential for app safety and functionality
- **App Continuity:** Some updates may be mandatory for the app to continue working properly
- User Safety: Security patches protect your data and device
- Enhanced Experience: New features improve your ability to use the app effectively
- **Compliance:** Some updates ensure compliance with app store requirements and regulations

4. Communication Methods

We will communicate updates through:

- Your calculator inputs or results
- · Your financial data
- Location data

5.3 Anonymous Analytics

We use anonymous, aggregated data to:

- · Understand which features are most popular
- · Identify areas for improvement

- · Prioritize which updates to develop
- Ensure updates work correctly across different devices

6. Update Frequency

- Security Updates: As needed, typically within 48 hours of identifying critical issues
- Bug Fixes: Regular updates, typically monthly or as issues are discovered
- Feature Updates: Periodic releases, typically quarterly or as new features are completed
- Major Updates: Significant changes announced in advance

7. Forced Updates

7.1 When Updates Are Mandatory

In certain circumstances, updates may be required:

- Critical Security Issues: Updates addressing serious security vulnerabilities
- App Store Requirements: Updates needed to comply with app store policies
- Legal Compliance: Updates required by law or regulation
- Service Compatibility: Updates needed for the app to function with our backend services

7.2 How Forced Updates Work

- Update Frequency: Check for updates manually instead of receiving automatic notifications

Important: You cannot opt-out of critical security and mandatory app updates, as these are essential for app functionality and security.

9. Compliance with Google Policies

Our update policy complies with Google Play Store requirements:
